Procedures for writing McIntire/State Annual REEport (CRIS) Reports

A. General Information

1. Background:

a.) What is REEport?

REEport (Research, Education, and Extension project online reporting tool) *is* NIFA's singular nonformula grant (including competitive) and formula grant project reporting system, building on and *replacing the existing Current Research Information System (CRIS)* web forms system.

As described in the REEport Manual "REEport is the vehicle through which NIFA performs its required data collection for research project initiation and progress reporting. This information collection is necessary in order to provide descriptive information regarding individual research, education, extension, and integrated activities and to document expenditures and staff support, as well as monitor the progress and impact of such activities."

2. What is a REEport (CRIS) Project?

a.) A REEport (CRIS) Project can be defined as:

A REEport (CRIS) project documents your McIntire-Stennis and/or your State proposal and is a two to four year activity at a single location. The activity focuses on a clearly definable problem, a manageable phase of a larger problem, or a few closely related elements of a broad-based program. In short Information for each REEport (CRIS) project includes:

- 1.) What is being done
- 2.) Who is doing it
- 3.) Where it is being conducted
- 4.) When it is being performed
- 5.) Who your efforts reached.
- 6.) Accomplishments achieved annually
- 7.) Impacts expected from the effort
- 8.) Publications associated with the work

The information from the Project Summary provides a basic abstract to describe a project. The Accomplishments Report furnishes an annual update of FTE's, products, impacts, and publications associated with each project. Additionally, funding expenditures and support years are reported by the FWRC, Administrative Officer each fiscal year via the Funding and Staff Support report.

3. Why is my McIntire-Stennis, State proposal also referred to as a CRIS/REEport Project?

- **a.)** All McIntire Stennis and State **proposals** entered in REEport become more commonly referred to as a REEport (CRIS) project upon acceptance and approval by NIFA.
- **b.)** The CRIS database (Current Research Information System) was **replaced** in April 2013, by REEport. Keep in mind both CRIS and REEport are acronyms and both systems were/are merely a database and set of webforms used for data collection by NIFA. While CRIS is no longer in use for data entry,

the acronym has not yet been replaced and the habit of this verbiage will likely be hard to change. It is also noted that information entered in CRIS prior to the release of REEport is still available to the public as a searchable Database.

4. FWRC and REEport

a.) FWRC is a participant of the REEport System and submits data annually by March 1^{st} of each year to NIFA. Data reported should include accomplishments on a Federal Fiscal year basis (Oct. 1_{st} – September 30th). Annual progress and/or Final reports are requested from the faculty and are due to the Grants and Contract Specialist no later than January 5^{th} of each year. See Section 6 for more information about preparing and submitting reports.

While McIntire Stennis, and State projects are reported on a Federal Fiscal year basis, NIFA competitive grants and cooperative agreements are reported on by anniversary date.

FWRC submits reports on all McIntire-Stennis, State, and other grants and cooperative agreements.

b.) Reporting Request

The Grants and Contracts Specialist will request FWRC annual accomplishment/final reports from the Principal Investigators (PI's) in late July to early August. The REEport System also sends a an email notification to each Project Director (PI).

The requests will contain the following items for the use and convenience of the PI:

- 1. The website to enter your report: <u>http://portal.nifa.usda.gov/portal/front/login</u>
- 2. Example of the report format and detailed instructions (Appendix A)

5. Should I write a Progress Report or a Final Report?

When your McIntire Stennis and/or State proposal was entered and approved by NIFA in REEport, the REEport system created a "draft reporting shell" for the type of report which is required for the corresponding yearlf you search the system by your name or your project ID number (Example: MIS-123456) you will see a "draft reporting shell" for the required reporting cycle which is due. A progress/final report will be listed under the "Draft Progress Report module or the Final Report module". Any completed reports will be listed in the relevant modules named "progress/final report submitted to NIFA".

6. Requesting an Extension

Remember, per NIFA the maximum project duration is 5 years. If your project was written and approved for on the 4 year duration; you may request a one year extension, however you will need to complete the request in the "Project Change" module in REEport.

7. Preparation and Submission of Reports

a.) Entering your Report In the REEPORT Portal (Appendix B):

- a. Enter the website at http://portal.nifa.usda.gov/portal/front/login
- b. Select FRST-MISSISSIPPI STATE UNIVERSITY-Forestry

- c. Select Progress Report, Final Report or Project Change.
- d. Enter your search criteria. (Best to use Project Number or Project Director) and select search.
- e. Select the draft report in which you need to work on.

b.) Items to be reported and completed for your report in the NIFA REEport Portal (Appendix C)

- a. Cover Page
- b. Participants (FTE's for the reporting year only)
- c. Target Audience
- d. Products
- e. Other Products
- f. Accomplishments
- g. Change Problems
- h. Submit

*Each of the above fields are limited to 8000 characters.

Final Reports will report FTE's for the last year only, however the report should include work done for the enter project period

c.) Submission of your report

When all fields have been completed select submit. At this point if any of the information contains errors, the system will notify of what corrections should be made. When corrections are complete select submit.

Save a pdf copy of your report, and forward the report to the Site Administrator for review and approval of the Associate Director and/or Dean.

Please remember submitting the report does not actually submit the report to NIFA. The report then goes in the Site Administrator's que for review and approval from the Associate Director and/or Dean. If no changes are requested the final submission will be done by the Site Administrator.
